**AN ACT**

**entitled**

***Bougainville Senior Appointments Committee (Appointment of Representative Members) Act 2006,***

Being a Bougainville law as required by Section 102(2) (*Bougainville Senior Appointments Committee*) of the *Bougainville Constitution*, to make provision for the manner of appointments of representative members to the Committee, and for related purposes,

MADE by the House of Representatives.

**1. INTERPRETATION.**

In this Act, unless the contrary intention appears –

“Bougainville Council of Churches” means the Bougainville Council of Churches, representative of the Churches of Bougainville;

“Bougainville Council of Women” means the Bougainville Council of Women;

“Committee” means the Bougainville Senior Appointments Committee established by Section 102 (*Bougainville Senior Appointments Committee*) of the *Bougainville Constitution*.

**2. SELECTION AND APPOINTMENTS, ETC., OF CERTAIN MEMBERS OF THE BOUGAINVILLE SENIOR APPOINTMENTS COMMITTEE.**

(1) The person appointed to the Bougainville Senior Appointments Committee to represent the Churches in Bougainville under Section 102(1)(c)(*Bougainville Senior Appointments Committee*) of the *Bougainville Constitution* shall be –

- (a) selected by the Bougainville Council of Churches who shall advise the President in writing of the name of the person selected; and
- (b) appointed to the Committee by the President by notice in the Bougainville Gazette.

(2) The person appointed to the Bougainville Senior Appointments Committee to represent the women of Bougainville under Section 102(1)(d)(*Bougainville Senior Appointments Committee*) of the *Bougainville Constitution* shall be –

- (a) selected by the Bougainville Council of Women who shall advise the President in writing of the name of the person selected; and
- (b) appointed to the Committee by the President by notice in the Bougainville Gazette.

(3) A person appointed to the Committee under Subsection (1)(b) or (2)(b) shall be appointed for a term of four years.
