**entitled**

***Revised and Additional Appropriation (2006) Act 2006,***

Being an Act -

- (a) to revise amounts appropriated in the *Appropriation (2006) Act 2005*; and
- (b) to authorize expenditure of additional moneys from the Consolidated Revenue Fund for the year ending 31<sup>st</sup> December 2006; and
- (c) to state in general and specific terms the purpose for or activities on which those moneys shall be expended,

MADE by the House of Representatives.

**PART I. – REVISED APPROPRIATION (2006).**

**1. AUTHORIZATION OF EXPENDITURE OF K98, 397,400 (AMENDMENT OF SECTION 2).**

Section 2 of the Principal Act is amended in the heading and in the text, in each case by repealing the amount “K98,397,400” and replacing it with the following:-  
“K93, 397,400”.

**2. APPROPRIATION OF K98, 397,400 (AMENDMENT OF SECTION 3).**

The heading to Section 3 of the Principal Act is amended by repealing the amount “K98,397,400” and replacing it with the following:-  
“K93, 397,400”.

**3. REPLACEMENT OF ESTIMATES OF REVENUE AND EXPENDITURE**

The Estimates of Revenue and Expenditure relating to the Principal Act are repealed and are replaced with the Revised Estimates of Revenue and Expenditure for the year ending 31<sup>st</sup> December 2006 attached hereto

**4. AUTHORIZATION OF ADDITIONAL EXPENDITURE OF K13, 000,000.**


