AN ACT

entitled

Autonomous Region of Bougainville Supplementary Appropriation (2007) Act 2007,

Being an Act to authorize the expenditure of public monies from the Consolidated Revenue Fund supplementary to the appropriation provided for in the *Appropriation (2007) Act 2006,*

MADE by the House of Representatives, to come into operation on certification.

1. INTERPRETATION.

In this Act unless the contrary intention appears, all words and expressions have the meaning provided in section 1 of the *Appropriation (2007) Act 2006,* save that –

“*Budget*” includes the document entitled “*Autonomous Region of Bougainville Supplementary Appropriation (2007) Act 2007*” to 31 December 2007”.

2. AUTHORIZATION OF ADDITIONAL EXPENDITURE.

Pursuant to Section 155 (*Financial Responsibility of the House of Representatives*) of the *Bougainville Constitution,* the House of Representatives hereby authorizes the expenditure, out of the Consolidated Revenue Fund, of amounts of money not exceeding, in total, K2,000,000, details of which are specified in the Budget Document entitled “*Supplementary Estimates of Revenue and Expenditure for the period ending 31 December 2007*”.

3. APPROPRIATION OF K2,000,000.

The amount authorized for expenditure under section 2 shall be appropriated to the votes specified in the “*Supplementary Estimates of Revenue and Expenditure for the period ending 31 December 2007*”.

4. APPLICATION OF OTHER PROVISIONS OF APPROPRIATION (2007) ACT 2006.

The provisions of sections 5 and 6 of the *Appropriation (2007) Act 2006* operate as if they were part of this Act.
