**AN ACT**

**entitled**

**Autonomous Region of Bougainville Appropriation (2008) Act 2007,**

Being an act to –

- (a) authorize the expenditure of public monies from the Consolidate Revenue Fund; and
- (b) state in general or specific terms the purpose for, or objects on which those public monies shall be expended; and
- (c) state the circumstances in which appropriation may be altered'

MADE by the House of Representatives

**1. INTERPRETATION.**

In this Act unless the contrary intention appears:-

“activity” means a sub-category of a function specifying an object in relation to any expenditure of public monies;

“appropriation” means allocation of a sum of public monies for a purpose or object, which is categorized in the Budget by a function, or a program, project, an activity or an item, and “appropriate” has a corresponding meaning;

“Bougainville Executive Council” means the Bougainville Executive Council established under the Bougainville Constitution;

“Budget” means the document entitled “Autonomous Region of Bougainville Appropriation (2008) Act 2007 to 31 December 2008;

“Division” means the Department under 590 and 290 as allocated by the Department of Finance and Treasury;

“function” means a primary unit of a classification specifying a Ministry, branch of Government structure or general purpose in relation to any expenditure of public monies.

**2. AUTHORIZATION OF EXPENDITURE OF EXPENDITURE OF K123,195,100**

Pursuant to Section 155 (Financial Responsibility of the House of Representatives) of the Bougainville Constitution, the House of Representatives hereby authorizes the expenditure, out of the Consolidated Revenue Fund, of amounts of money not exceeding , in total K13,195,100 details of which are specified in the Budget Document entitled “ Estimates of Revenue and Expenditure for the period ending 31<sup>st</sup> December 2008.”

**3. APPROPRIATON OF K123, 195,100**

The amount authorized for expenditure under Section 2 shall be appropriated to the votes specified in the “Estimates of Revenue and Expenditure for the period ending 31 December 2008.

**4. APPROPRIATION OF CONDITIONAL GRANTS, ETC.**

Conditional Grants and such other monies lawfully made available from the National Government towards Restoration, Rehabilitation and Reconstruction are appropriated for expenditure through the Consolidated Revenue Fund.

**5. ADJUSTMENT TO AMOUNTS APPROPRIATED WITHIN FUNCTIONS.**

The Bougainville Executive Council may make adjustments to amounts appropriated to votes within the budget:-

- (a) in respect of Recurrent Expenditure by -
  - (i) transferring within functions, amounts from one activity to another activity; and
  - (ii) transferring within functions, amounts from one item to another item; and
  - (iii) transferring amounts between functions; and
  - (iv) creating new functions and activities; and
  - (v) creating new functions an activities; and
  
- (b) in respect of Public Investment Program Expenditure by -
  - (i) transferring within functions, amounts from one project to another project, and from one activity to another activity or from one item to another item; and
  - (ii) transferring amounts between functions; and
  - (iii) creating new functions and projects; and

**6. TABLING OF STATEMENT OF ADJUSTMENT.**

As soon as practical after the end of the financial year, the Bougainville Executive Council shall table at the meeting of the House of Representatives held no later then 31 March 2009, a statement dealing with adjustment to the appropriation as at the end of 31 December 2008.
