## Council of Elders (Amendment) Act 2010

Being an Act to amend the Bougainville Council of Elders Act 1996.

MADE by the House of Representatives.

# 1. COMMENCEMENT

This Act shall come into operation on a date approved by the Minister and published in the Bougainville Gazette.

## 2. INSERTION OF NEW PART VA OF THE PRINCIPAL ACT

The Council of Elders Act 1996 in this Act referred to as the 'Principal Act' is amended by inserting after Part V the following new Part VA. -

# "PART VA. - VALIDATION OF ACTIONS OF COUNCILS OF ELDERS

## 23A. APPLICATION OF THIS PART

This Part applies to the Councils of Elders specified in the Schedule whose terms have expired but no elections have been held.

# 23B. VALIDATION OF ACTIONS, ETC., OF COUNCILS OF ELDERS

- (1) A Council of Elders referred to in Section 23A whose term has expired in accordance with Section 22 but no elections has been held to elect or appoint new members of that Council under Sections 19 and 20 and has continued to function as if its term has not expired must-
  - (a) be deemed to have validly performed such functions conferred upon it under this Act or any other law; and
  - (b) be deemed to have validly exercised any powers conferred on it under this Act or any other law.
- (2) Any-
  - (a) decision made; or
  - (b) expenditure made or committed; or

(c) agreement or contract entered into; by a Council referred to in Section 23A pursuant to its powers under this Act or any other law is deemed to have been validly made.

#### 23C. CARETAKER COUNCIL

- A Council of Elders referred to in Section 23A is deemed to be a Caretaker Council and shall continue to function as such until elections are held under this Part and a new Council is established.
- (2) In carrying out the functions and exercising the powers of a Council of Elders, a Caretaker Council:
  - (a) must take account of the intention of Parliament that it is acting in the role of caretaker pending the election and appointment of members of the Council of Elders; and
  - (b) must not, without the prior consent of the Minister in writing, initiate any major new policy or major change to existing policies; or
  - (c) must not effect any major change to the staff of the Council of Elders.

### 23D. ELECTIONS

Elections under Sections 19 and 20 for a Council of Elders referred to in Section 23A must take place on a date determined by the Minister after consultation with the Bougainville Executive Council and published in the Bougainville Gazette."
