6. GOVERNMENT NOTICE OF MOTION APPOINTMENT OF THE MEMBERS OF BUSINESS COMMITTEE

Mr. Thomas Pata'aku (Leader of Government Business) moves –

- 1. THAT subject to Standing Orders 155, this House establishes the *Parliamentary Business Committee* and appoints membership of the Business Committee.
- 2. THAT the membership of the Parliamentary Business Committee shall consist of:
 - (1) Hon. Simon Pentanu, Speaker, who shall be the Chairperson; and
 - (2) Hon. Therese Naru Kaetavara, Deputy Speaker, who shall be the Deputy Chair; and
 - (3) Hon. Thomas Pata'aku, Leader of Government, as a committee member representing the Bougainville Executive Council; and
 - (4) Hon. Amanda Masono Getsi, Member for Women in North Bougainville, as a committee member representing women members in the House; and.
 - (5) Hon. Jacob Tooke, Chairperson of South Regional Committee, as a committee member, representing Chairpersons of Regional Committees.
- 3. THAT the functions of the Parliamentary Business Committee are:
 - (1) To meet each Monday and on each sitting day before the House meets.
 - (2) To examine all notices of motion lodged with the Clerk.
 - (3) To consider any government prioritized business brought to the attention of the committee by the Leader of Government Business.
 - (4) To determine the order of Private Members' Business appearing on the Daily Programme to be considered on each sitting day.
 - (5) To ensure that government business, private members' business and committee reports are given appropriate amount of time for the House to consider during each meeting.
 - (6) To perform any other duties provided for in the Standing Orders.
- 4. THAT the House notes that
 - (1) the quorum of the Business Committee shall be three members; and
 - (2) if a quorum of the members of the Business Committee is not available at the time fixed for the committee to meet, the functions of the committee shall be exercised by the Speaker in consultation with the Leader of Government Business.
- 5. THAT the appointment and membership of the Parliamentary Business Committee shall be published in the Bougainville Gazette.
